We consider you a member organisation as of 1 July 2023. The EPSU affiliation fee will be invoiced to your union from 1<sup>st</sup> July 2023 onwards. This invoice will be sent to you in the next few days. Please note that PSI will send you a separate invoice.

For the year 2023, the fee is EUR 0,445 per member multiplied by 25 % (GDP index of Kazakhstan). It means that your organisation will have to pay 56,25 EUR (for 10.000 members, for 6 months).
